NOMINATIONS AND ELECTIONS: Chair, Annette Hill, reported the following committee activities that ensured a successful election: distributed voting/election information to the membership via Robo Calls and flyers, held successful election via absentee ballots and in-person voting, transferred ballots to the Dekalb County Board of Registration and Election to ensure integrity of the voting process and assisted with organizing the Installation of Officers. The Election Board recommended use of a Chain of Custody Form; the Committee will either adopt or create one for the next election.

Ericia requested that members prepare for a membership update. LWSC is the largest Center in Dekalb with over 3,000 members. Renewal forms can be retrieved online or at the Front Desk. Social Workers will be at the Center on Tuesdays and Wednesdays from 9:00 am to 12 noon to complete the in-person intake and update each members information. The mandatory signed medical release form from your physician is good for 90 days. The membership fee will be waived for three months.
